- St. Louis County has started the construction work on Bayless Avenue. Mayor Puleo has a call into St. Louis County regarding the new sidewalks. Mayor Puleo checked with St. Louis County regarding the set-back distance for Akron's new fence. The neighbors will sign off on their agreement to the new fence.
