NO PERSONAL CHECKS. Payments may also be made at **TRAFFICPAYMENT.com or by calling 800-444-1187** with credit or debit card. Clerk cannot process credit or debit cards.
- 2. Following the 5<sup>th</sup> business day after receiving the Summons: Pay the fine(s) and court costs <u>in person</u> at the Traffic Violations Bureau located at City of Bella Villa City Hall located at 751 Avenue H, Bella Villa, MO 63125 Monday 10am to 4pm, Tues-Wed 8am to 4pm, Thursday 8am to 2pm, Closed Fridays.
