MAYOR'S REPORT: MAYOR PULEO

- A resident placed a toilet on the curb. Mayor Puleo contacted Waste Management and requested the toilet be removed. A letter will be sent to the resident reminding them bulk pick-up is available monthly from Waste Management, but a call must be made requesting the service.
- The city wide garage sale will be held June 16, 2018.
- It is time for the newsletter to be written and circulated. The city wide garage sale and a reminder about bulk pick-up from Waste Management will be included.
- The entrance to George Appel Park needs to be widened to allow the access of fire equipment. The Lemay Fire Department has expressed their concern with the current entrance.
- Mayor Puleo attended an MSD meeting. While there she showed MSD employees pictures of the sewer at the entrance to George Appel Park that is blocked by the new curb. MSD feels the curb is there in error. The sewer is meant to receive water from all sides.
- MSD was called to clean out the above sewer but they cleaned out the wrong one. MSD has been contacted again to clean the correct sewer.
- The speed limit sign on Avenue H at Bayless has been put back in the ground.
- There was a water main break on Fawn Circle February 27, 2018. A temporary fix has been done. The permanent work will be finished in the next 8 10 weeks.

POLICE REPORT: CHIEF WELGE

- Officer Brandon Thomlinson was introduced to the Board. He is a potential part-time police officer.
- Car #2 was backed into by a driver during a traffic stop. Only the license plate was damaged. A new license plate will be bought.
- The resident at 705 Ruprecht contacted Chief Welge because a neighbor is placing construction waste in their trash cans.

TREASURER'S REPORT: JIM MAJEWSKI

- A budget review meeting is scheduled for 4/26/18, at 6:30 pm.
- Treasurer Majewski spoke with an employee of McManus Construction. He said when they were salting the City streets it took them approximately 1.5 hours to go through the entire City versus the 6 hours claimed by our current contractor.

- Commissioner Lotspeich received a call regarding a resident on Dallas Drive that parks their car facing the wrong direction for days at a time. Officer Navratil has spoken to them about this.
- Commissioner Lotspeich received a call regarding a lot of activity at night at a home on Dallas. Chief Welge will have the Officers keep an eye on this home.
- Commissioner Lotspeich received a call regarding a garage on Ruprecht. The caller said there is constant activity in the garage day & night. Commissioner Lotspeich learned the owner's brother was living in the garage. She has since put him out.
- There is construction at a home on Hoffmeister. Commissioner Lotspeich asked

Commissioner Franklin to check on the activity with regards to permits.
